



## Municipality of Northern Bruce Peninsula Council Meeting Highlights November 25, 2024

The following is a summary of the proceedings of the Special Council Meeting held on November 25, 2024:

- Council received a report from the Treasurer regarding 2025 Municipal Community Funding Requests.
- Presentations were conducted by 19 organizations whose requests exceeded \$500.
- Council reviewed request from organizations for funding requests of \$500 or less and in-kind requests for the waiving of rental fees for Municipal facilities.
- A report from the Treasurer will be presented to Council on December 9, 2024, regarding the Community Funding Requests.
- It was noted that further deliberations surrounding the 2025 request will be conducted at the December 9, 2024, Council Meeting.

The following is a summary of the proceedings of the Regular Council Meeting held on November 25, 2024:

- Council approved the minutes of the Council Meeting held on November 12, 2024, and the minutes of the Special Council Meetings held on November 20, 2024.
- A Public Meeting was held regarding the 2025 Fees and Charges By-law.
- A Public Meeting was held regarding Zoning By-law Amendment File No. Z-2024-063 (Loney).
- Council received a delegation from the Bruce Peninsula Family Centre regarding a request for the construction of a new exterior access door within the childcare centre.
- Council received a delegation from John Rodgers, representing the Bruce Peninsula Biosphere Association, regarding the Stokes River.
- Council authorized staff to enter the active bidding process for the procurement of a used 1996 Cat 816F Landfill Compactor.

- Council received a report from the Public Works Manager regarding the 2024/2025 Winter Control Handbook.
- Council received a report from the Fire Chief regarding the 2025 Emergency Plans.
- Council received a report from the Deputy Clerk regarding the Short-term Accommodation Licensing Program, - 2024 Review.
  - It was noted that the report will be placed on Let's Talk NBP for a period of 30 days commencing November 26, 2024.
- Council received a report from the Chief Administrative Officer regarding Block 62 Plan 3M-199.
- Council received a report from the Chief Administrative Officer regarding an additional staffing complement request.
- Council approved the October 8, 2024, minutes of the Museum Committee.
- Council received the approved Accounts Payable Voucher for October 2024, in the amount of \$2,981,748.73.
- Council received several items of correspondence as information.
- Council approved four By-laws, a By-law to authorize a Winter Service Agreement with the Bruce Peninsula National Park, a Zoning By-law Amendment, and a Confirmatory By-law.
- Council **deferred** A By-law to adopt a Sale of Unopened Road Allowance and original Shore Road Allowance Policy.
- Following Closed Session, Deputy Mayor Anderson advised that the Council approved the minutes of November 20, 2024, closed session meeting and Council provided the CAO direction with regards to personnel and Ontario Land Tribunal hearing discussions.
