

## Municipality of Northern Bruce Peninsula Council Meeting Highlights May 13, 2024

The following is a summary of the proceedings of the Regular Council Meeting held on May 13, 2024:

- Council approved the minutes of the Regular Council Meeting held on April 22, 2024, and the minutes of the Special Council Meeting Re: Road Tour held on April 26, 2024.
- A Public Meeting was held regarding Zoning By-law Amendment Z-2023-092 (Ziolkoski).
  - Following the Public Meeting, Zoning By-law Amendment Z-2023-092 (Ziolkoski) was not approved by Council.
- Council received a delegation from Save Georgian Bay surrounding the TC Energy Pumped Storage Energy Plant.
- Council received a report from the Committee and Licensing Coordinator regarding proposed amendments to the Short-term Accommodation Licensing Program.
  - Council directed the Committee and Licensing Coordinator to expand the Short-term Accommodation Licensing Program to rural and commercial zones, reduced the cap to 500 licences, and excluded rural and commercial zones from obtaining Class C Short-term Accommodation Licences.
  - It was noted that existing Class C licences in Rural and Commercial Zones would be grandfathered.
  - It was noted that a report regarding the approved amendments will be presented to Council at the May 27, 2024, Council Meeting.
- Council received a report from the Public Works Manager regarding the 2023
   Tobermory Primary Place Centre Drinking Water System Annual Report.
- Council received a report from the Public Works Manager regarding the Eastnor Work Shed Repairs.
- Council received a report from the Chief Building Official regarding the Proposed cell tower -75 Lindsay Road 40 "Additional Information".

- Council received a report from the Chief Building Official, which was deferred at the April 22, 2024, Council meeting, regarding the Proposed cell tower -75 Lindsay Road 40.
  - Council provided direction of non-concurrence surrounding the proposed
     Cell Tower at 75 Lindsay Road 40.
  - A copy of Council's decision was forwarded to the Innovation, Science and Economic Development Canada (ISED).
- Council approved a Trailer Agreement for 64 Howard Bowman Drive.
- Council approved a Trailer Agreement for 208 Greenough Point Road.
- Council received a report from the Parks and Facilities Manager regarding the RFP Results for the Lion's Head Community Centre Building Condition Assessment.
  - Council accepted the proposal from Facility Risk Solutions Ltd., in the amount of \$9,850.00 + HST
- Council received a report from the Parks and Facilities Manager regarding the RFP Results for the Building, By-laws, and Parks and Facilities Departments.
  - Council accepted the proposal from Owen Sound Honda for the supply and delivery of three (3) new 2024 Honda CRV AWD EX-L Hybrid SUV's in the colour white in the amount of \$147,638.76 + HST.
- Council received a report from the Municipal Law Enforcement Officer regarding 2024 Bylaw Enforcement Officer Appointments.
- Council authorized an agreement between Parks Canada and the Municipality of Northern Bruce Peninsula regarding a letter of agreement for parking on Chi sin tib dek Road.
- Council authorized an agreement for the sale of daily family/group entry permits to Bruce Peninsula National Park at Little Cove Road.
- Council directed staff to submit the Municipality's comments to the Niagara Escarpment Commission (NEC), regarding the Development Permit application for Part Lot 2, Concession 10 EBR, Municipality of Northern Bruce Peninsula (Eastnor), County of Bruce.
- Council directs staff to submit the Municipality's comments to the Niagara Escarpment Commission (NEC), regarding the Development Permit application for Lot 18, Part Lot 19, Concession 8 EBR, Municipality of Northern Bruce Peninsula (Lindsay), County of Bruce.
- Council authorized the CAO to execute and Agreement between the Municipality
  of Northern Bruce Peninsula and StrategyCorp Inc. for Intergovernmental
  Services and Relationship with the County of Bruce research.
- Council received a report from the Chief Administrative Officer regarding the 1<sup>st</sup> Quarter Operational Report.
- Council received the approved Accounts Payable Voucher for April 2024, in the amount of \$1,151,874.41.
- Council approved the minutes of the April 2, 2024, Museum Committee meeting.

- Council approved the minutes of the April 24, 2024, meeting of the Chi Cheemaun Committee meeting.
- Council approved the minutes of the April 29, 2024, Municipal Drainage Committee meeting.
  - Council supported the increasing of the Beaver Bounty from \$25 to \$30 to match the bounty offered by Bruce County.
  - Council supported the utilization of the Fire Department Drones by the Drainage Committee for monitoring drains upon request.
- Council approved the minutes of the April 30, 2024, Cemetery Committee meeting.
- Councillor Golden resigned as the Grey Bruce Detachment Joint Board.
  - Council appointed Councillor Dowd to the Grey Bruce Detachment Joint Board.
- Council received several correspondence items as information.
- Council requested staff to schedule a delegation with Parks Canada surrounding the National Marine Conservation Areas General Regulations.
- Council requested legal opinion surrounding the operation of E-Bike Rentals at the Meeting Place as it pertains to insurance.
- Council directed staff to submit delegation requests for the arena and water projects to the appropriate ministers for the 2024 Association of Municipalities of Ontario (AMO) Conference.
- Council directed staff to work on parking issues identified at Bruce Peninsula District School.
- Council denied a request for a crossing guard at Bruce Peninsula District School.
- Council approved nine by-laws, a By-law to Authorize a Software Licence Agreement between Park Pass Inc. and the Municipality of Northern Bruce Peninsula, a By-law to Appoint the Community Member to the Grey Bruce Detachment Joint Board, a By-law to Authorize an Agreement with Golden Dawn Seniors Home for the Provision of Shuttle Services Within the Village of Lion's Head, two by-laws imposing special annual drainage rates upon land in respect of which money is borrowed under the Tile Drainage Act, a By-law to Authorize an Agreement with Parks Canada for the Collection of Parking Fees on Chi sin tib dek Road, a By-law to Authorize an Agreement with Parks Canada for the Sale of Daily Family/Group Entry Permits to Bruce Peninsula National Park at Little Cove Road, a By-law to Appoint Municipal Law Enforcement Officers and Property Standards Officers for the Municipality of Northern Bruce Peninsula, and a Confirmatory By-law.
- Following Closed Session, Mayor McIver advised that Council approved the minutes of the April 8, 2024, Closed Session meeting and direction was given to the CAO surrounding human resource issues.
